FinMan Training coming soon...

The FinMan training course and financial guide will be structured in the following sections:

- Introduction to the Project Cycle Management (PMC)
- Preparing the proposal
- Project Financial Management
- Reporting System
- Audit

Each part will include case studies, best practice examples and tips from experienced project management professionals. The materials will be practical, user-friendly and generic to the range of different EU funding programmes.

Don't miss the Test Run in Portugal!

When and where?

The training course will be tested in Porto in a two days workshop from February 16-17 2012.

What?

In those two days the focus will be on the following topics:

- Module 2 Preparing the proposal
- Module 4 Reporting System

The module on project financial management (module 3) will be addressed but will not include practical expercices. The modules on project cycle management (module 1) as well as on financial audit (module 5) will be introduced briefly.

It was decided to focus on those contents that contain the most practical exercises and case studies. Furthermore, the participants will have the opportunity to integrate their own practice examples from real projects in the discussions and ask concrete questions. Those questions will be collected already at registration stage in order to prepare and include them as best as possible in the workshop.

Who?

The two days test run addresses participants with some experience in project management!

How?

Grants are available to cover travel and subsistence costs for pilot test participants, if you would like to take part, please, contact the project partner in your home country for available spaces and registration procedures. The registration ends by 16 January 2012.
